Athlete Check-In – 10 A.M. Prejudging – 12 Noon (approximate). Evening Show – 6 P.M.

ELIGIBILITY: Open to all amateur athletes who possess a current INBF card (\$35) or who obtain one the day of show. Athletes must be drug free for 7 years from the date of show. A WNBFF Pro card will be awarded to the Overall Winner in the Open Men's & Women's divisions (provided that there are a least 5 people in the division). The Figure division overall winner will receive WNBFF Figure Pro Card (if at least 5 in the class). **Promoter reserves the right to reject late entries.**

FEES: Entry fee: \$35 Crossover \$25 Polygraph testing: \$40 payable on day of test.

AWARDS: 1st to 5th place in each bodybuilding weight class and overall. Figure & Fitness: 1st to 5th place.

MUSIC: CD or cassette tape must be preset to a *maximum of 60 seconds.*

I also agree to submit to any and all out-of-season testing required by INBF and agree to stand by the results of said testing, whatever it may be.
